**TERMS**

**FULFILLMENT OF ORDERS.** Dealer will submit all orders for Howler Products on the Howler Purchase Order Form in effect from time to time or in such other manner as is prescribed by Howler. All such orders will be subject to acceptance by Howler. Howler will use commercially reasonable efforts to fill all accepted orders within a reasonable period of time, and may make partial shipments in connection therewith. Dealer's sole remedy in the event Howler is unable to fill any accepted order shall be to cancel the order by giving written notice to Howler prior to such order being shipped.

**PRICING.** The price for Howler Products ordered by Dealer (including any applicable discounts) shall be as set out in the Howler dealer price list in effect for Dealer's country on the date such order is received by Howler. Howler may change the dealer price list in effect from time to time without notice to Dealer.

**SHIPPING.** All shipments are FOB Howler's warehouse located in Austin, Texas. Dealer is responsible for paying all freight, duty and taxes and insurance charges for the Howler Products from the Warehouse to final destination. Howler, at its sole option, may arrange for shipping and insurance on behalf of Dealer with common carriers and insurers satisfactory to it and prepay such charges. Any such charges will be added to the invoices submitted by Howler to Dealer. All risk of loss relating to ordered Products passes to Dealer at the time such Products are delivered to a common carrier for shipment to Dealer, whether such carrier was selected by Dealer or Howler, and Howler shall not be responsible for any delays in shipment or loss or damage to Howler Products following such delivery.

**PAYMENT TERMS.** Remit Payments to: Howler Brothers, 3800 N. Lamar Blvd, Suite 730-303, Austin, TX, 78751. Dealer agrees to pay Howler for all Howler Products ordered prior to delivery unless Howler has, in its sole discretion, determined to extend credit to Dealer. Where such credit has been extended, all invoices for Products will be paid by Dealer within thirty (30) days of the invoice date unless otherwise provided on the invoice or agreed in writing with Howler. Overdue accounts will bear interest at the rate of 1.5% per month (18% per annum) until paid. Howler may suspend shipments of Howler Products until all overdue accounts and related interest charges have been paid in full. Any dispute as to invoices must be reported to Howler within thirty (30) days of the invoice date. After such period invoices shall be deemed correct and be binding upon Dealer.

**RETURNS.** Returns of Howler Products will not be accepted unless Dealer has previously obtained a return authorization from Howler. All warranty returns will be repaired, replaced or credited at the discretion of Howler. Inventory returns, if accepted by Howler, will be subject to Howler's restock fee and other charges as Howler may impose from time to time.

The information contained in this application is for the purpose of approving purchases and obtaining credit and is warranted to be true. The Dealer agrees to pay all bills according to the terms and policies of Howler Brothers. This agreement becomes binding only when accepted and executed by Howler Brothers.
